AHCCCS Updates

Regional Behavioral Health Authority

Throughout the first quarter of 2020, AHCCCS will be hosting a series of community forums to provide information and solicit feedback from the community on AHCCCS initiatives on RBHA services. Electronic Visit Verification

On December 5, 2019, CMS granted AHCCCS request for an extension for meeting the Electronic Visit Verification (EVV) requirements. CMS specified that they do no have authority to extend the compliance deadline beyond January 1, 2021. Additional information and guidance regarding EVV is available on the <u>AHCCCS website</u> The link gives access to a Power Point presentation from state's EVV vendor, Scandata Systems. The tool describes Arizona's provider type, coding, and place of service requirements for EVV.

Arizona Complete Care Health Plan and RBHA Updates
